8 Open Forum for public participation

An opportunity to hear from members of the public, Borough and County Councillors

The Chairman thanks the public for their patience whilst the groups were being decided.

Resident asked where is the site of the residential development in Crown Street with 30 dwellings, is it at the bottom of Church View? The parish council are not aware of an additional application for 30 dwellings, which would require planning permission, a non-material amendment has been received recently for changes to a wall.

Members of the planning committee will investigate.

Will a list of all the Committees and groups be available on the parish council website? These will be available in the minutes.

CIL money – does this include a payment for the fence on the recreation ground? There is a specific list which CIL can be used for.

Has CIL been received for the Hythe Road & Herbert Drive developments? Clerk to check.

The fence on the Church View development and the recreation ground was shown on the planning application/development plan, Clerk to check the details and chase with planners.

The state of the car park at the old social club is a disgrace, the Chairman explained this is a Trust matter but that the contractor had met with the Chairman this week, and this will be rectified.

How do the public contact the Trust? Chairman explained how the parish council and the trust communicate.

Weed spraying around the village, when will this be done, the whole village looks a mess. Clerk to follow up.

The Old Chapel – is there an update, what is happening with the site, the hoarding, and the parking? This will be bought up again with Highways and Borough Council.

Speedwatch on Stoke Road at 3pm when the children are coming out of the school, did you record anyone speeding? Cllr. Minkler reported that this was the wrong time to hold a speedwatch session in this venue because traffic was moving slowly due to the traffic parked along this road.

There are vehicles parking overnight in St George's Car Park, what can be done to stop this? There is already a sign saying no overnight parking, it is very difficult to stop this. Closing the gate was considered but there is a cost associated with this and might have a knock-on effect for hall users. There is already a no overnight parking sign on the entrance to the car park.

Cllr. Storey joined the meeting at 8.20pm and apologised for his lateness which was due to another meeting. A couple of meetings ago a councillor asked Cllr. Storey a question regarding the UK 100 – the parish council were not given the opportunity to discuss or vote on this, how much is it going to cost?

Cllr. Storey asked the councillor (who was not present) to send him an email requesting the information so that he can reply.

It is the season for annual meetings for parishes and the county council.

An email has been received from the Greenscape Officer at the Borough Council informing the parish council that after conducting a health & safety review of all the dog bins in the parish they empty all 8 dog bins are either too high or too large, the problems have to be rectified by 20th May otherwise the bins will not be emptied. Other local councils have received this email and have sent letters to the leader of the Borough Council to object, an email will be sent from Methwold Parish Council. New bin in Globe Street and Methwold Hythe will be set at the regulation height. Cllr Rodriguez proposed to permit the installation of a dog bin at Globe Street end of rec. and on the corner in Methwold Hythe, cost for new bin is approx. £200 + VAT and will incur additional cost of £190.32 for BCKLWN to empty this bin and the one in Methwold Hythe which is to be replaced. Cllr. Horton seconded the motion – APPROVED

- 12.2 Speedwatch and SAM sign report for April/May SAMs2 the parish council are responsible for the SAMs2 unit, Cllr. Minkler and a volunteer are looking after the placement and data for this machine.

Community Speedwatch Group - co-ordinated by Cllr.Minkler

12 active members of which 2 live in Methwold

The group covers 3 villages over 5 official locations

The group now has two sets of equipment eg: speed device and signs with enough members two different locations can be covered at the same time.

Methwold Hythe has the biggest issue with speeders but no local volunteers.

Monthly stats from the Police for April have been delayed because of holiday, these will be available for the next meeting however we are likely to be the highest in terms of hours covered.

Using figures from the SAMs sign we can now evaluate the contribution of Speedwatch and its effectiveness. Charting one particular day in Brookville when the Speedwatch group attended for 1.5 hours. It can clearly be seen that the usual 30% speeding traffic was reduced to 6% while the sign session was on. Most of the traffic travels throughout the day at 40mph. Approx. 4000 vehicles per day.

SAMs2 Sign

There are 8 official locations for the sign throughout the 3 villages, 7 are active. One post is missing near the new builds on Hythe Road Methwold opposite the public path. This has been chased up with Highways and will be speaking to the Highways Engineer.

The SAM sign padlocks have been replaced and a duplicate set of keys is now with the clerk for safe keeping. Another set is with the Speedwatch volunteer who has been trained to relocate the sign as per the schedule in my absence.

The SAMs sign has a new schedule to move every Monday over the 8 locations and as the Memorandum of Understanding, the sign will not return to any location before 8 weeks have passed.

Statistics: information is downloaded after each week at each location. Any amount of statistics can be obtained from the sign but for comparison of locations it is best to look at just 3 identifiers – maximum speed, average speed of speeders and the percentage of traffic over the speed limit.

Figures for 3 sites for comparison

Brookville 40mph (incoming traffic from Stoke Ferry)

Max: 90mph (on 15/4 at 01.25am)

Average Speeder: 46mph which would result in a fixed penalty

Percentage traffic over the speed limit: 30%

Methwold 40mph (On Stoke Road at the crossroads with High Street incoming from Brookville)

Max: 80mph (on 03/05 at 05.40am)

Average Speeder: 45mph under the fixed penalty speed

Percentage traffic over the speed limit: 10%

The Hythe 30mph

Max: 50mph (late afternoon)

Average Speeder: 35mph which would result in a fixed penalty

Percentage traffic over the speed limit: 60%

These statistics show that Methwold Hythe has an issue with speeding and not enough resources in the CSW team to keep monitoring the Hythe, Cllr Minkler asked for the councils permission to hand deliver a notice to all houses in Methwold Hythe asking for volunteers to come forward and help run Speedwatch sessions in Methwold Hythe, the council were given a copy of the notice and all agreed to this.

The council agreed to post the notice on the parish council website and on their Facebook page. Cllr. French suggested that a monthly SAMs and Speedwatch report might be published in Methwold Times.

Cllr Minkler proposed to letter drop the leaflets in Methwold Hythe, Cllr. Grassick seconded – APPROVED Clerk to make contact with the Editor.
